



- interesting read on consensus and humming
- (not discussed in more detail today, just for reference)







## F. Discussion of open policy proposals (1)

- 2012-02
  - "Policy for Inter-RIR transfers of IPv4 Address Space"
  - end of review phase reached April 17
  - no clear consensus
  - proposer working on re-wording policy text in the hope to gain more understanding and possibly stronger support
  - nothing to discuss yet



## F. Discussion of open policy proposals (2)

- 2012-03
  - "Intra-RIR transfer policy proposal"(bring back timeline to 24 months)
  - withdrawn because 2012-06 half-reached the same goal (back to 12 months), and 2013-03 (no need) works the same front



## F. Discussion of open policy proposals (3)

- 2012-04
  - "(IPv4) PI assignments from the last /8"
  - withdrawn because unlikely to reach consensus



## F. Discussion of open policy proposals (4)

- 2013-02
  - "Removal of requirement for certification of reallocated IPv4 addresses"
  - review period has ended, strong support
  - now in WG last call
  - no need to discuss, unless one of you wants to bring up objections



## F. Discussion of open policy proposals (5)

- 2013-03
  - "No Need Post-Depletion Reality Adjustment and Cleanup"
  - presentation by Tore Anderson
  - and hopefully a lively discussion :-)
